

**TALK TO HARVEYS 2012 CUSTOMER PERCEPTION SURVEY
SWEEPSTAKES OFFICIAL RULES
No Purchase Necessary to Enter or Win
Purchasing Anything Will Not Improve Your Chances of Winning**

Open only to legal residents of FL, GA and SC
who are 21 years of age or older. Void where prohibited by law.

ELIGIBILITY: This Sweepstakes is open to residents of FL, GA and SC who are 21 years of age or older at time of entry. Employees of Harveys Supermarkets ("Sponsor"), Questar, The Sweepstakes Center, (collectively, the "Sweepstakes Entities") and their affiliates, subsidiaries, advertising and promotion agencies, and such employees' immediate family members and/or persons living in the same household are not eligible. To enter by participating in the survey, from 12:00 am Eastern Time ("ET") on January 19, 2012, through 11:59 pm ET on November 9, 2012 (the "Sweepstakes Period"), each time you make a purchase at a participating Harveys store you may receive an invitation which has a store number on it. If you receive one of these invitations, call the toll-free number listed or visit www.TalkToHarveys.com to complete a short survey about your Harveys shopping experience and be automatically entered in the sweepstakes. Even if the survey quota has been met, you will still be able to enter the sweepstakes.

NO PURCHASE OR SURVEY COMPLETION NECESSARY: To enter by mail, see the store manager for the 4-digit store number that will be required to take part in the sweepstakes. On a standard size postcard or 3" x 5" paper hand print the 4-digit store number along with your name, address, city, state, zip code, age and phone number and mail it to: Harveys Sweepstakes, P.O. Box 16440, Rochester, NY 14616. Mail-In entries must be postmarked by 11/9/2012 and received by 11/16/2012.

In the event of a dispute over the ownership of an e-mail address, the prize will be awarded to the Authorized Account Holder of the designated e-mail address.
